- No details have been submitted to show how the Lime Trees which have TPO'S on them will be protected when the access is created.
- The visibility splay is shown with the Lime Trees brash going through it obscuring the visibility when using this junction. Does this mean the brash will be cut back for the visibility splay as this could cause damage and disease to these protected trees?

The Avenue of Lime Trees are a special feature to our Conservation Village and are to be protected. Therefore, request this application to be deferred until the Councillors have received and discussed the requested information.
