### **Public Session**

A 15-minute public session was held prior to the Council commencing the meeting. Members of the public were invited to raise any matters they wished to discuss, however they were not guaranteed an answer at this meeting. Should there be a requirement for the council to provide responses, the matters raised will be listed on the agenda for the next Ordinary Meeting of the Council. 1 member of the public was present, and a question was asked about the cricket club rent. It was **AGREED** that the Clerk and the representative of the cricket club would review the data regarding the number of adult and junior games and cancellations. It was also **AGREED** that the representative would review his costings of cricket club and develop a proposal for the meeting on the 17<sup>th</sup> of January 2024.

- 2023/165 There was an introduction from the Chairman and a reminder of the Council's expectations for the audio or visual recording of this meeting.
- 2023/166 Apologies were received from Councillor Kay and reasons for absence approved.
- **2023/167** Declaration of Interests

- 2023/174 A donation to Great Ouseburn Youth Club was considered and it was RESOLVED to pay £18.00 per session rent.
- **2023/175** The rate of £42.00 per hour for clearing out the fishponds was approved for an estimated 4-5 hour's work.
- The action log was received, and it was **RESOLVED** to buy 2 new footpath signs and materials at a maximum cost of £300.00. It was **AGREED** that the Clerk would chase up the dog bins with NYC.
- 2023/177 EV charging was considered, and it was **AGREED** to close the issue as there are underused points in the vicinity. It was **AGREED** to review the item in a year.
- **2023/178** The Clerk provided an update on the freelanding.
- The commuted sums projects and potential projects were reviewed. Councillor Bainbridge agreed to circulate the finalised commuted sums spreadsheet.

Potential ideas included; old people's shelter, developing wildlife and a delineated car park at the freelanding, installing hardstanding at Churchfield Lane opposite the new graveyard, moving the source of the River Ouse monument, (it was **AGREED** that Councillor Scott would arrange a meeting with the owner, Councillor Jackson and himself), youth club equipment, the creation of a circular walk in the village (after

checking the viability), Pipers Lane pond requires gullies to stop the pollution of the pond, bus stop/bus shelter.
