

Minutes of a meeting of the Parish Council held on Wednesday 15th January 2020 at 7.30 p.m. in the Jeff Gill Room, Village Hall, Great Ouseburn.

2019. 0135 Public Participation. Any member of the public present at the meeting may make representations, answer questions or give evidence in relation to the business to be transacted. Members of the council who have a prejudicial interest in relation to any item of business to be transacted also speak in relation may to that Please note that the Chairman will control this session and will exercise his discretion as to the amount of time allowed for public participation. No decisions are made at this part of the meeting – this will be done by the Council having heard and noted the representations made:

Re: 2019.139.11: Playing Field: In the Play Area Inspection Report it was stated that the cricket sight screen is not to be stored on the basketball area. The cricket club representatives suggested a compromise for the goals to be able to swivel in and out. Mark Tankard stated that he will undertake to ensure the PC that he will remove the sight screen at the end of the cricket matches.

The Cricket Club suggested that the play area fence is currently too low and at risk of cricket balls flying into the Childs play area and harming children. They would like it higher to prevent this. DM spoke to the YLCA for advice and it is recommended that the PC carry out a Risk Assessment. Mark Tankard of the Cricket Club stated he recognised that this is a joint responsibility between the PC and cricket club. PC agreed that more notices need to be erected in the play area and one in the basketball area stating that when a cricket match is on there is a risk/danger of balls impacting the area and parents should supervise their children at all times.

GOPlay is still looking into the issues of the goals. This may have to be compromised on both sides.

2019.0141.01 Mr Butler, Cedar Croft, Main Street, Great Ouseburn, York YO26 9RG 6.80.21.D.LB 19/04179/LB Listed building consent for replacement of water damaged concrete and tile floor: no objections

2019.0141.02 Mr Mark Davies, Land to the rear of Avenue House, Branton Lane, Great Ouseburn YO26 9RS 6.80.157.D.FUL 19/05295/FUL Land to the rear of Avenue House, Branton Lane, Great Ouseburn, York YO26 9RS: OBJECT – The Councillors object for the following reasons:

- 1) The Driveway is not a road and is restricted to a drive due to the TPO's on The Avenue trees. Any widening of the access would require removal of a tree with a TPO on it which is not acceptable. The neighbouring development with the public house had a limit of 5 houses maximum at the rear. NYCC should be consulted if this access drive is to be joined to a neighbouring development and to create an access road as it will require a full specification like the development on the other side of Avenue House for 9 houses.
- 2) The developments are impacting and destroying the gap between the 2 villages of Ouseburn and Branton
- 3) The site to the East although currently having planning permission for 9 houses still does not have a sustainable design for the road access from Branton Lane and so should be disregarded as far as views are regarded as it may possibly never be built. This development will therefore impact on the important view stated in the Conservation area document from the village green looking across The Seggans.
