2016.142.01 Mr and Mrs S Beale Galtres Cottage, Branton Lane, Great Ouseburn, York, North Yorkshire YO26 9RT 6.80.175.BFUL 17/00129/FUL Formation of replacement driveway: The Councillors discussed this application and wish to object on the following grounds:

- Referring to the highways response to the original application to convert into 2 houses this is not a suitable location for a 2nd access.
- The site line drawn towards Cedar Cottage is blocked by Cedar Cottages wall and garden planting area which is higher than 800mm.
- The average speed along the road is in excess of 30mph
- The scale of the drawing is not accurate
- The proposal has insufficient off road parking for the size of the property.
- No turning area which creates a problem of reversing onto a busy road on a blind bend. This may
 create on street parking near a blind bend.
- The plan does not show the driveway access to The Croft.
