The new location is to be indicated on the plans as it needs to be in close proximity to the existing location. Cllr Scott raised that he noticed on HBC website that the Parish Council have not been consulted regarding The Forge development requesting plastic windows as should be under the Article 4 Directive. Clerk to e-mail planning and Cllr Lewis to be made aware also.

16th April 2014

Councillors brought up concerns about the building taking place at 'The Forge' as they are not as per the consulted planning application due to the use of plastic windows. The Chairman was informed by the planning department that the parish response was not received. This is incorrect as the Clerk copied the Chairman in on the e-mail that was sent in response. The Council also claim to have sent consultations regarding the plastic windows plus other large alterations. These were not received by the clerk. The clerk is to consult with Councillor Lewis of how to proceed with the planning department as these problems started when they asked us to go electronically in responding to applications rather than staying with the paper format which was more reliable.

Cllr Lewis is requesting a meeting between the Parish Council and Harrogate Borough Council to discuss their decisions and also asking for the Council to supply the Conservation Report that sanctioned these conditions. Cllr Lewis informed the council the Bus Stop has to be placed in the location as per plans.

2014.51.02 Mr Graham Heatley, Unit 3, Peasholme Court, Stonebow, York, North Yorkshire, YO1 7AD Re: The Forge, Main Street, Great Ouseburn, York YO26 9RF 6.80.188.C.DVCON 14/01886/DVCON Delete or Vary Condition – Variation of condition number 2 to allow alterations to approved plans and erection of conservatory of planning permission 6.80.188.C.DVCON: Application retracted 16.06.14 as HBC had to check dimensions and measurements of what has actually been built. Application resubmitted on the 18.06.14: The Parish Council discussed this application and objected due to the following observations:

- The pitch of the roof is too high and is causing concern as the house is located adjacent to the village green and is an important site location with it being a conservation village. It is such a large house intimidating and dominating the houses surrounding it.
- No chimneys present as shown on the original plan which changes the look of the building and not in keeping with the village.
- The Art stone jams are not satisfactory.
- The style of windows does not reflect the requested sash design particularly the lack of horns on the windows which are normally required for the period of the village.
- Additional windows have been added since the original plan particularly on the gables which are not desirable and overlook adjacent properties.
- The property has been built too close to next door and not where agreed on the original plan which causes it to overlook adjacent properties.

Wednesday 16th July 2014

• The Forge, Main Street: A meeting took place today with planners and councillors.

The original plan is now to be dismissed however, the new plan submitted by Cosy Homes had certain criteria missed off the plan of which Harrogate Borough Council said they were negligent for due to workload at the time. Therefore the property is left with an enlarged footprint. The planners accepted a footprint of 8.3 however the builder has built the property to a footprint of 9m which is in breach therefore has been told to re-submit new plans of how the building has actually been built. The Parish Council should be consulted on these new plans of which they will not be accepting and have the following concerns and will object to:

- Increase in height of the building
- Moving of the footprint towards the old forge cottage and is overbearing to this adjacent property and dominating the street scene.
- The property has gained 450mm in length including the garage (20.4m on the plan passed and actually built to 21m). This has brought it closer to the old forge cottage.
- Window Jams on the side of the windows should not be there and are out of keeping with the period of the village.
- The Porch is also out of keeping and is a different style and is bigger than what was approved on plan.
- The window in the garage is too close and overlooking the adjacent property.
- The Velux roof window nearest to the Forge Cottage (West End) is overlooking the adjacent property.

The clerk is to contact Harrogate Borough Council and request a copy of the Environmental Survey/Report.

21st January 2015

Cllr Rampling raised concerns that The Forge development have still not paid their Commuted Sums and that this may money become lost to the Parish if left until April when the commuted Sums scheme may change. It was requested for the clerk to chase Harrogate Borough Council and to copy in Cllr Lewis.

18th March 2015

It was reported that the company 'Cosy Homes' of Forge House has been struck off from Companies House as being insolvent. Therefore any outstanding monies need to be chased personally.

21st October 2015

New Forge House: Harrogate Borough Council is enforcing the legal agent of the house in connection to the window jams and porch. No commuted sums have been received to date. Cllr Lewis has been informed the building company are in liquidation
