

Minutes of a meeting of the Parish Council held on Wednesday 22<sup>nd</sup> July 2015 at 7.30 p.m. in the Jeff Gill Room, Village Hall, Great Ouseburn.

- 2015. 58 Apologies received for absence: Cllr B Robinson (Vice Chairman), Cllr M Grant, Cllr C Lewis (Harrogate Borough Council).
- 2015. 59 **Declarations of Interest.** All Parish Councillors are Trustees of the Village Hall and declare their personal interests in the Village Hall. Members to indicate whether they will be declaring any other interests under the Code of Conduct.
- 2015. 60 **Minutes of the previous meeting.** To confirm the minutes of the meeting held on Wednesday 24<sup>th</sup> June 2015: The minutes were agreed as a true and correct record plus signed and dated by the Chairman.
- 2015. 61 **Public Participation.** Any member of the public present at the meeting may make representations, answer questions or give evidence in relation to the business to be transacted. Members of the council who have a prejudicial interest in relation to any item of business to be transacted may also speak in relation to that matter. Please note that the Chairman will control this session and will exercise his discretion as to the amount of time allowed for public participation. No decisions are made at this part of the meeting this will be done by the Council having heard and noted the representations made:

## 2015. 62 **Progress Reports.** To receive progress reports as follows:

2015.62.1 LDP Affordable Housing Site, Branton (minute 2012.074 refers): Still pending until the 1<sup>st</sup> July 2015. Cllr Scott reported that he had seen on Harrogate Borough Council planning website that there was some alterations had been submitted to the planning application: Shows various visibility splays, 2 accesses have been removed from Carr Side Road plus taken the majority of garages out. There are 2 footpaths shown to go from the development onto Carr Side Road. Carr Side Road is a narrow lane and doesn't have a footpath at these points. This is deemed to be unsafe and requires a footpath to be provided.

Houses at the entrance off Branton Lane need to be removed as the green space between Great Ouseburn and Branton villages needs to be maintained. An access put where the first two houses are to give the Green Space back. This area has also been submitted by the Parish Council to Harrogate Borough Council to be considered and protected as a Green Space.

The current drainage is already inadequate in this vicinity and the proposed development will exacerbate the problem.

- 2015.62.2 The Free Landing: The grass has been topped again by Cllr Potter. The wood that has been left at the free landing still requires burning. The area also requires strimming.
- 2015.62.3 Highways issues: The potholes on the footpath along the Avenue from Ouseburn to Pipers Pond have deteriorated together with the footpath on Main Street from Roxby Cottage to Light Mire Lane. The Councillor's suggested a site meeting to show the problem areas and to copy County Cllr John Savage in on the e-mail. The double white lines on the main Boroughbridge road have also broken and require reporting.
- 2015.62.4 Tree Management: Cllr Robinson kindly offered to strim around the bottom of the 2<sup>nd</sup> tree on The Avenue: There is a dead tree at Pipers Pond. Request Nigel Roskilly to remove.
- 2015.62.5 Commuted Sums: Payment has not yet been received for the allotment works. Waiting for Sean Wright to return from holidays.

- 2015.62.6 Fishpond conservation area: The ragwort needs removing.
- 2015.62.7 Allotments: 1) Mrs D. Johnson letter dated 29.06.15 requesting permission to place various items within the allotment plots: no objections.
  - 2) Mr J Sizer, Tannery House requesting to purchase the allotment plot on completion of the sale of the house from the Jones family in August 2015: The Parish Council is not selling any land/allotment plots at this present time.
  - 3) Nathan Culpan of Ainsty (2008) Internal Drainage Board letter dated 01.07.15 re: Parish Council recent drainage works: Cllr Chris Lewis e-mailed the drainage board to request their boundary map. The Parish Council is still awaiting the map to be provided.
- 2015.62.8 Gladman Developments Ltd Possible development of the Seggans: This has been withdrawn.
- 2015.62.9 Children's Play Area: An Engineer is looking at the roundabout tomorrow and then will send a quotation.

'The Parish Council strongly object to the proposed use of Witherans Lane for domestic use as is being granted under Harrogate Borough Council Planning Department. As an adjoining landowner you have no right of passage over this land.

Church Field Lane is a private road owned by the Parish Council and maintained by North Yorkshire County Council. Therefore we do not give permission to cross the grass verge with a vehicle.'

- **2015.63.6** Mr & Mrs Walker, Jasmine Cottage, Main Street, Great Ouseburn, York YO26 9RE Enforcement: 15/00195/PR15 The site was visited and it was confirmed that a dark green tank was sited in the front garden against the boundary wall. The tank is modest in size and due to its colour it is not considered to cause any harm to the Conservation Area. Our Enforcement investigation has therefore been closed: read out by the chairman.
- 2015.63.7 15/00020/PR15 17 Branton Close, Great Ouseburn, York, YO26 9SF application 14/02813/PDUCO was refused in 2014, I am advised that revised application (15/02411/PDUCO) for a smaller fence has been submitted but at the moment is invalid as

a location plan & scaled elevational drawings, showing the dimensions and appearance of the proposed fence, are required. Once these are received the application will be validated and the Parish Council consulted as usual. Read out by the chairman.
