2013.011 **Declarations of Interest.** All Parish Councillors, as Trustees of the Village Hall, declared a personal interest in the Village Hall.

- 2013.014 Progress Reports.
 - 2013.14.1. Free landing/Breathing Places project (minute 2011.110.1 refers). The pothole at the entrance is currently outstanding and will be done shortly scalping's have now been obtained.
 - 2013.14.2. **LDP Affordable Housing Site, Branton** (minute 2012.074 refers): The consultation notification period will take place between the 10th May and 21st June 2013. A special meeting will be organised for the parish and a leaflet drop in the village will take place to notify all residents.
 - Cllr Lewis's 'Sewage' e-mail was circulated to all councillors regarding the blockages that are going to be investigated.
 - 2013.14.3. **Allerton Waste Recovery Park** (minute 2011.110.2 refers). Cllr Potter recently spoke informally to NYWAG to see if they would help Great Ouseburn Parish regarding the LDP site but are not in a position at the present time to help.

NYWAG have requested a donation from Great Ouseburn Parish Council towards their funding against the Incinerator. It was discussed with various views amongst the councillors due to not having a great deal of funds spare to donate to keep monies for Great Ouseburn Parish with the looming LDP Housing Site. It was also agreed that it was not the councillors decision to make on how to spend the resident's money therefore the residents of the village should be asked their opinions and go on the casting vote whether or not to make a donation. Cllr Lewis believes we should hold a special meeting in the beginning of June inviting residents to attend and inform the public of the plans for the Incinerator, LDP Housing Site and Cold Calling and hear their views. The planned date for this will be the 12th June 2013 at 7.30pm in the Village Hall.

The Environment Agency letter dated the 30th April 2013 regarding the Environmental Permit Application – EPR/NP3034CG/A001 was read out to all present by the chairman.
