Mike Rampling wished to report the following items:

- 2) The footpath on Branton Lane running from The Avenue trees to Tarragoo has sunk and in general disrepair.
- 3) The pothole has still not been repaired on the Village Green on the left handside going from the village hall across towards Carr Side Road.
- 4) Pipers Pond needs dredging as a H&S issue (Cllr Robinson volunteered to get a quote to do this).
- 5) Regarding the ongoing development at Abeokuta. Mr Rampling states that this is being built incorrectly. The builders have recently put an Italian type slate roof on which is shiny. Mr Rampling's neighbouring property 'Tarragoo' cannot look out of his kitchen window as it is blinding (sunspots) between the period of 1-6pm. Mr Rampling has written to the Planning department reporting this and requested for the clerk to also on his behalf.

- The Seggans is an ancient wetland home to much wildlife including rare species for example such as Barn Owls, Badgers, Crested Newts, Bats and rare plant life.
- Due to the proposed access being on Seggans Road, this is shown that the road would be widened. The Councillors object to this as this forms part of the Conservation Village Green area.
- Due to the amount of proposed housing it would involve possibly 30+ cars using this junction wish is not safe as the Village Hall junction is currently hazardous when pulling out.
- Drainage issues The village has ongoing problems as already at full capacity and concerned the overflow will affect Ousegill Beck which is home to many rare and endangered plants and wildlife.
- This development is visually infringing on the historical view over the ancient wetland of the Seggans from the Conservation village green. This is against the Harrogates local policy.
- No access should be granted through The Avenue which can damage the Lime Trees with TPO'S on them.

- The large proposed increase in development within the village will change the culture of the village.
- There are not enough facilities within the village to support extra housing.
