- 2011.173. Apologies for absence were accepted from Cllr J Savage, Cllr M Leather, Cllr J Burton, Cllr M Grant
- 2011.174. **Declarations of Interest.** All Parish Councillors, as Trustees of the Village Hall, declared a personal interest in the Village Hall.
- 2011.175. **Minutes of the previous meeting** held on Wednesday 16th November 2011 having been previously circulated were approved and signed by the Chairman as a true and correct record.

 - 2011.177.1. Freelanding/Breathing Places project (minute 2011.110.1 refers) no further updates
