

Minutes of a meeting of the Parish Council held on Wednesday 18<sup>th</sup> April 2018 at 7.30 p.m. in the Jeff Gill Room, Village Hall, Great Ouseburn.

- 2018. 1 To receive apologies and approve reasons for absence: Cllr D Meakin, Cllr R Kay and NYCC Police.

- 2018. 3 **Minutes of the previous meeting.** To confirm the minutes of the meeting held on Wednesday 21<sup>st</sup> March 2018: The minutes were amended by Cllr Scott regarding Mr C Beggs-Reid then approved, signed and dated by the Chairman.

Dr Jones has done a lot of Committee work in the past and now would like to become involved in the village and surrounding area. The Councillors voted by coopting Dr Jones into the Parish Council. Cllr Jorgensen proposed and Cllr Wilkinson Seconded. All in favour of Dr Jones being elected.
