

Minutes of a meeting of the Parish Council held on Wednesday 21st March 2012 at 7.30 p.m. in the Club Room, Village Hall, Great Ouseburn.

2011.211. Apologies for absence were accepted from Cllr Lawrence Paterson, Mr G Potter

2011.212. **Declarations of Interest.** All Parish Councillors, as Trustees of the Village Hall, declared a personal interest in the Village Hall.

2011.213. **Minutes of the previous meeting** held on Wednesday 22nd February 2012 having been previously circulated were approved and signed by the Chairman as a true and correct record.

2011.214. **Public Participation.** Cllr Leather informed the Parish Council:

Harrogate Borough Council move into one property is going ahead subject to planning.

Affordable Housing LDF and Core Strategy are to change.

The new recycling schedule is to commence in June.

2011.215. Progress Reports.

- 2011.215.1. Freelanding/Breathing Places project (minute 2011.110.1 refers) The clerk is to contact the solicitor to chase up the agreement for the riverside path. If this doesn't get completed shortly the car park will have to be closed.
- 2011.215.2. Allerton Waste Recovery Park (minute 2011.110.2 refers). Planning application NY/2011/0328/ENV. Awaiting the report from Amey Cespa regarding the roads.
- 2011.215.3. High Speed Rural Broadband (minute 2011.110.3 refers). This has been installed into the Village Hall (20MB) and will be installing into houses next week which have requested it. There is a demonstration this Saturday the 24th to be held in the Club Room at the Village Hall.
- 2011.215.4. Church Field Lane sign (minute 2011.110.4 refers). The sign has now been installed.
- 2011.215.5. Highways issues.

Cllr Leather informed the clerk that a street light is out on Carr Side Road and to be reported to Highways.

Large pothole on Carr Side Road was reported and filled in.

Cllr Rampling met with the Aboriculturist Alan Gilliard of Harrogate Borough Council with regards to the Lime Trees down Church Field Lane to assess the damage to the trees. Mr Gilliard sympathises and believes it to be pure vandalism and is putting a complaint into planning therefore if this happens again they will be able to press legal charges. However, The Limes will recover from the damage and will cost approx. £100 in remedial works. The clerk is to obtain some quotes for the work. The Limes will not be able to have a tree preservation order installed due to their location not having a visual impact. (Not sited on a main road or over looked by any houses).

2011.215.6. Proposed Article 4 Directive, Conservation Area (minute 2011.110.6 refers). Naiomi Kempton Senior Conservation Officer is to produce a document regarding the guidance of planning under the Article 4 Directive regarding visual impact from the highway/street scene. The clerk is to see if this has been produced yet.
