

Minutes of a meeting of the Parish Council held on Wednesday 19<sup>th</sup> July 2017 at 7.30 p.m. in the Jeff Gill Room, Village Hall, Great Ouseburn.

- 2017. 64 **To receive apologies and approve reasons for absence** Cllr B Robinson (Vice Chairman), Cllr R Kay and Cllr G Bush, Cllr A Paraskos (NYCC), PCSO Jan Powel & PCSO Philip Wright (North Yorkshire Police)
- 2017. 65 **Declarations of Interest.** All Parish Councillors are Trustees of the Village Hall and declare their personal interests in the Village Hall. Members to indicate whether they will be declaring any other interests under the Code of Conduct.
- 2017. 66 **Minutes of the previous meeting.** To confirm the minutes of the meeting held on Wednesday 21<sup>st</sup> June 2017: Approved, signed and dated by the Chairman.

No decisions are made at this part of the meeting – this will be done by the Council having heard and noted the representations made.

A member of the public raised concerns over a possible dam being built at Fishpond Bridge under the new proposed scheme. Together with the Sugar beet planning application the possibility of Ousegilll Beck becoming polluted from waste of the factory – Cllr Scott updated the resident.

The 30mph flashing sign is currently not working and needs reporting to NYCC to fix.

Pipers Lane nameplate near Pipers Pond (one side) spelling still needs to be replaced.

- a) NYCC Boat Lane Grass Path: The Inspector made a site visit and was happy with the example and just needs it authorising by his manager.
- b) Moor Lane issues: The Gills of Moor Lane Autos Ltd are currently parking trailers on the highway/ bridleway. The councillors requested the clerk to write them a letter to clarify again that this land is owned by the Parish Council and was agreed that in the past they were to maintain the roads and verge rather than the parish council charging rent.
- c) The Chairman also requested a letter to be written to the owners of the land where Nuzzlets are based as they have fenced off an area of land that belongs to the Parish Council.

- e) Village name trough outside Sandlands, Main Street to discuss: The name trough volunteer has resigned. Trish Meakin has kindly offered to take this role on and all agreed for the Parish Council to reimburse for plants.

- 2017. 073 Tracey Rathmell Harrogate Borough Council letter dated 13 July 2017: Harrogate District Local Plan: Additional sites consultation 14 July 25 August 2017 deadline for comments 25<sup>th</sup> August: Great Ouseburn Parish Council object to the Green Hammerton development It will join 4 communities together, Kirk Hammerton, Green Hammerton, Whixley Gate and Cattal Station.

There is no employment in the current vicinity/community – The Doctors at Green Hammerton are already at capacity. These factors need addressing and taking into consideration.

The proposed development will be built on high quality agricultural land.

There is only a single track railway line at Cattal and Kirk Hammerton with limited parking. Whereas the Flaxby site it is a dual track.

The A59 traffic is already at full capacity without adding a further 3000 houses. The road network system is better at the A1 Flaxby development.

As per our previous consultation Great Ouseburn Parish Council fully support the Flaxby development and not the Green Hammerton development

The Parish Council has an agreement with the Cricket Club to use it on the Saturday afternoons during cricket season.
