 - 2019.110.2 The Free Landing a) Platform repair update: on hold
 - 2019.110.3 Highways issues: to report 1) pothole o/s Cedar Croft opposite the Church on Main Street, it is around a manhole cover and breaking up. 2) pot hole outward bound on Carrside road just before Campbell & pentys. 3) Street light out on the corner of the Seggans Lane on the green.
 4) street light out on the junction of Main Street/Carrside Road and Branton Lane 5) Great Ouseburn name sign missing from the junction of Carr Side Road and B6265.
 - a) Dog waste bins: Susie Hunter-Smart has now volunteered on a trial basis to empty the Church Field Lane dog bin on a weekly basis and will see how this goes. b) Traffic calming/speeding on Brown Lane north of junction with Pipers Lane: The chicanes have now been installed. Road painting is outstanding together with the reflective tape.
 - 2019.110.4 Tree Management: Tree in play area needs mesh putting around it as children are peeling off the bark. Cllr Kay kindly said she will sort.
 - 2019.110.5 Commuted Sums: to submit form to Sean wright (hbc) to apply for commuted sums for a new parish noticeboard and for the play area.
 - 2019.110.6 Fishpond conservation area a) proposal to discuss Mr Fred Jackson memorial: Grant received for Ecology Pond/wildflowers. Topped the wetland area. Part of the grant is for the Interpretation Board. 2 quotes have been received; 1) Landmark £2093 + vat 2) Red Bonsai £2120 + vat. All Councillors voted for Red Bonsai as used before. Work is on track for mid-December.
 - 2019.110.7 Allotments: TCV have cleared the plot and the natural pond is doing really well.
 - 2019.110.8 Children's Play Area: HBC Great Ouseburn Play Area Annual Inspection Report 2019 to discuss: The report was discussed. The Cricket sight screen needs to be removed from the basketball area.

a) GOPlay update: Beer Festival donated £800. The public consultation closes on Sunday where 3 play area options are to view and comment on. 1) Kompan 2)Playscheme 3) Playdale. If a grant was approved work could start in April/May 2020. Clerk is to request a £1000 grant from Cllr Paraskos NYCC.
