2. The reference in the guidelines to evicting people off the field: The cricket Club expressed that they are unhappy that they are not given permission to remove people off the field. The Chairman could not see this on the form. It was agreed by all that this is true, and they cannot stop people being on the field as it is a public field as long as they do not interfere with the cricket match. The following paragraph is to be added to the end of the document:

'No user of the playing field can restrict by any means the use of any part of the playing field by the public unless they are interfering with the hirers use of the playing field.'
