Minutes of the meeting of Great Ouseburn Parish Council at 7.00 pm on 22nd November 2023 in the Committee Room of the Village Hall

Public Session

A 15-minute public session was held prior to the Council commencing the meeting. 2 members of the public were present, and no questions were asked at this stage.

- **2023/145** There was an introduction from the Chairman and a reminder of the Council's expectations for the audio or visual recording of this meeting.
- **2023/146** Apologies were received and reasons for absence approved from Councillors S. Wilkinson and R. Kay
- 2023/147 Declaration of Interests

a) Declarations of interest not already declared under the council's code of conduct or members Register of Disclosable Pecuniary Interests received included Councillor Scott who declared a non-pecuniary interest in planning application 6.80.209.D.FUL ZC23/03752/FUL.

- b) There were no applications for dispensation received.
- **2023/148** The minutes of the meeting held on 18th October 2023 were approved and signed as a true and accurate record of proceedings. (These were circulated under separate cover).

- 2023/150 Clerk's report

If no response is received from the Operations Manager, then the next stage is to take legal action.
