Fishpond Bridge was not repaired as informed during the Easter holidays. The update is that it is still in Design Stage.

Highways are reviewing the road signage on the Boroughbridge road junction with Little Ouseburn and at the junction of Carr Side Road with regards to the diverting of traffic to the Toll Bridge and Linton on Ouse. It currently diverts all traffic through Carr Side Road and the main section of the village unnecessarily rather than just heavy goods vehicles.
